



# Rules and Regulations

- The term 'Organizers' shall mean 'Shringaar', having its registered office in Mumbai. The term 'Exhibitor' shall include all employees, staff and agents of any company, partnership firm or the individual to whom the space has been allocated for the purpose of participation.
  - TERMS OF PAYMENT :** All payments are to be made by means of payee Account Cheque/DD drawn in favour of 'Shringaar / PJ News & Information Bureau Pvt. Ltd.', payable at Mumbai. Outstation payments are to be made by means of DD only. 50% of the payment needs to be made at the time of booking and the balance 50% must be received at least 1 month prior to the exhibition so that the necessary possession letter can be given to the exhibitor for taking physical possession of the stalls. No payments are to be made in cash. The organizers will not recognize any such cash payments and will not be responsible for the same.
  - FORFEITURE AND RE-ALLOTMENT OF STALLS :** If the total payment is not received one month prior to the exhibition, the organizers reserve the right to cancel the booking and forfeit the payments made and reallocate the stalls. In the event of cancellation, no refund of advance paid will be made under any circumstances as the construction of your stall would have been completed.
  - ALLOCATION OF STALL :** Allocation will be on first come first serve basis, on receipt of completed exhibit space booking form with requisite payment. Subleasing of any part of the stall is strictly prohibited and illegal. Stalls are not transferable and cannot be shared. One fascia will be displayed per stall booking form. The display of goods shall be in accordance with that mentioned in the booking form. Any other products sold/displayed will be confiscated and the organizers reserve the right to close the entire stall and claim monetary compensation in the case of defaulters.
  - No Exhibitor shall be permitted to exhibit unless he has paid prior to the exhibition all of the fees agreed.
  - MODIFICATIONS :** Any changes in the stall structure, provision of facilities etc. are to be undertaken by the approved contractors only. Any additional facilities required in the stall, which will be provided at extra cost. The request for the same should be writing in the appropriate forms to the organizers on or before one month in advance. The exhibitor shall have no right whatsoever to use/block any area of the exhibition other than the area allocation to him. The organizers reserve the right to modify the layout of the stall, gangways and pathways etc. Entrance/Exit to 'Shringaar' is as per the layout. No banner etc. will be allowed in the exhibition premises or on the roads in vicinity unless their design specifications, installation and location have been approved by the organizers, without which a penalty will be levied.
  - STALL INTERIORS :** All stall interiors and decoration should be completed two hours prior to the inauguration of the event. While the exhibitors are free to decorate their stall, they should not cause any damage to the walls, panels and floors through use of nails, painting or any other such activity.
  - Exhibit shall not obstruct the view of adjoining exhibit nor be operated in any manner objectionable to other exhibitors. All lighting within the exhibit must be arranged and operated so as not to be distracting to adjacent exhibits. Phonograph radios or other sound devices operated in a manner objectionable to the Exhibit committee shall be prohibited.
  - Exhibitor shall not permit raffles or other promotional measures that require members or guests to be present at a specified location and time, and all unusual promotional plans must be approved by the Exhibit Committee.
  - SECURITY :** The organizers will make general security arrangements only. However, participants should take all possible precautions and will be responsible for the security of their goods and stall displays. Individual security arrangements should be made only through an approved agency and the guard on duty must be introduced to the organizers. No claims on theft/loss will be entertained by the organizers. Security arrangements are participants' responsibility. Entire exhibition will be closed and opened in front of stall holders' hence all the stalls and belongings are the responsibility of the exhibitor only.
  - BUSINESS LICENSE / TAX :** It is the participant's responsibility to obtain necessary licenses for making any sales and transacting other business and pay taxes. Levies, duties etc. on their own. The organizers are not liable for any such taxes, levies, duties or consequential penalties as may be incurred by the exhibitor.
  - INSURANCE :** Participants will have to insure their exhibits, display materials against loss, damage, theft, fire, rain, cyclone & earthquake or any other causes, whatsoever. The organizers shall not be liable/responsible in any way for personal injuries and material damage of the exhibitor or his staff, agent invitees, or licensee and damages to the exhibits, however caused.
  - CONSEQUENTIAL LOSS :** In case of the exhibition being canceled or suspended in whole or in part for causes not in the organizers' control, the organizers do not accept any consequential liability in any such eventuality. And refund will not be made under any circumstances. The organizers reserve the right to change the venue and dates of the exhibition without assigning any reason, whatsoever and refund will not be applicable in such cases.
  - The organizer will endeavour or ensure supply of essential services at the venue. As the supply of such services is not within the control of the organizers, the organizers are not liable for any loss or damage. If any such service shall wholly or partly fail or ceases to be available, no refund partly or wholly will be made.
  - VIOLATION OF RULES :** In the event of the violation of the rules or if the exhibitor indulges in activities against the guidelines, the organizers reserve the right to close down the stall of the participant immediately.
  - VACATION OF SPACE :** The allotment space will have to vacated with in 19.00 hrs. on the last day of the exhibition. No material will be taken out of the premises without valid exit gate pass from the organizers which will be issued in the evening of the last day of the exhibition. Any verbal agreement by the organizers concerning any aspect of this contract of the event is not valid unless confirmed in writing. The organizers shall have the right to make any changes or add any new clauses in the rules and regulations as they deem desirable.
  - DISPUTES :** Any dispute between the organizers and the participant is subject to jurisdiction of the courts of Mumbai City only.

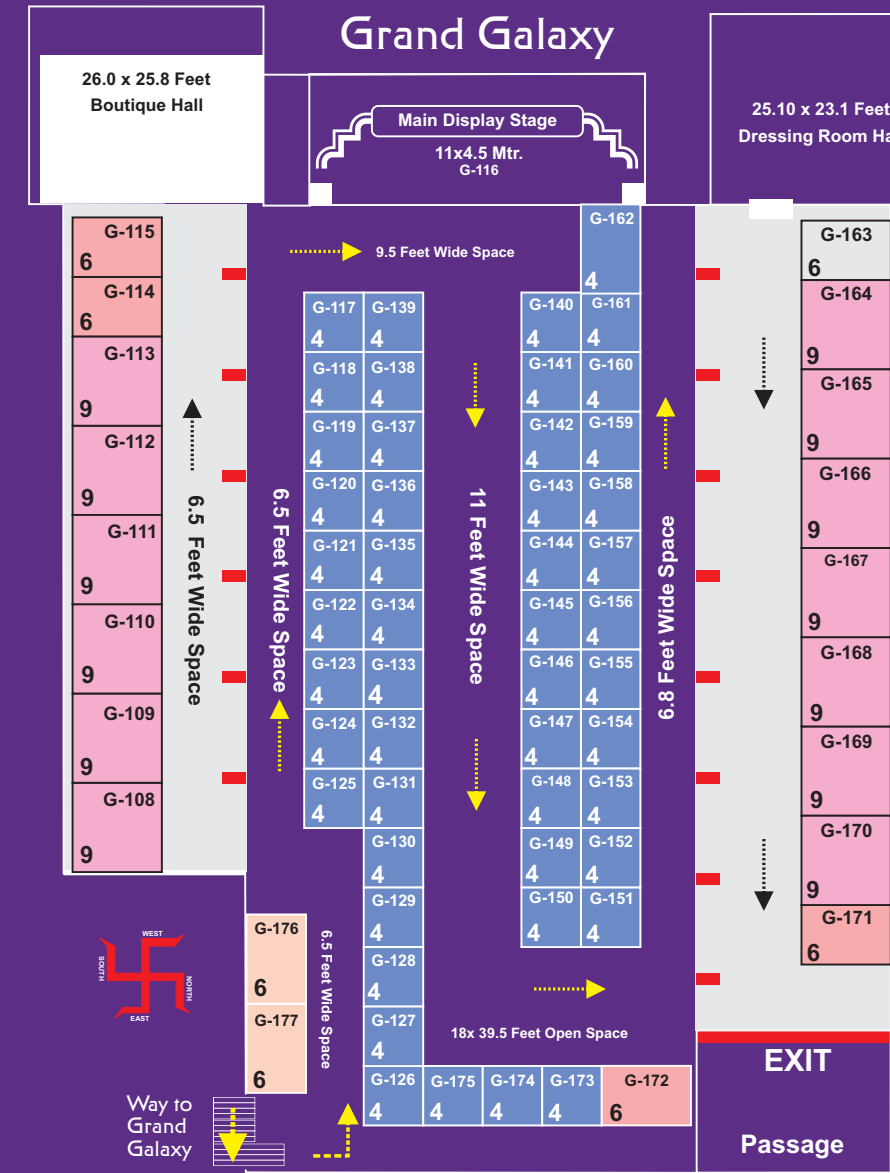
